# DAY 1: Tuesday 19th of July 2022

#### Welcome addresses and Opening

Dr Mario Paiano from CM welcomed partners and then, he opened the technical session.

# **IO3- READ-COM App – Finalization of the Output**

Introduced by Mario Paiano together with Prof. Dolores Madrid, the current state of the art of the App have been analyzed by all partners, highlighting the lacks to be improved and the aspects to be refined. The necessity to accomplish all these commitments respecting last deadlines was strongly underlined by the Coordinator UMA and all partners agreed to make their most to finalize in the best way the App in time.

To date a lot of the activities prepared and sent in the first half of May 2022- for example – by Spanish and Portuguese partners had not yet been received by the Greek technical expert due to technical problems. So, a new schedule to close the work for the App was approved by all partners and accepted by UMA as Project Coordinator.

The following operational issues have been discussed and shared among all participants, including the technical expert from Greece:

- App's refinement;
- Recovering and re-sending of the activities already prepared by UGR, Rosa De Galvez and AJEJD to the Greek technical expert George Birbilis, to be uploaded on the App;
- Sending of the activities prepared by MMU and Ist. GIovanni XXIII (ICTB) to the Greek technical expert George Birbilis, to be uploaded on the App;
- Total number of activities to be included in the App;
- Specific age range for the activities proposed by partners;
- Updated work schedule to finalize the App.

These aspects as well as the tasks assigned to each organization as defined during the technical session are all summarized in table here below.

# **PROJECT ASSESSMENT - Final Project Evaluation**

Mr. Paiano showed the main features of the whole project assessment: progress evaluation and final evaluation, including the impact assessment.

The evaluation of project's progress has been done using **quantitative** and qualitative indicators that focused on:

- the accomplishment of the project's outputs
- the accomplishment of specific coordination actions such as the transnational project meetings
- the accomplishment of the project's training events (LTTA)
- the <u>dynamic of collaboration</u> among partners.

The monitoring and evaluation process guaranteed to pursue within the READ-COM project:

- the *assessment* of the whole management process and of the results gradually achieved by the project
- the *compliance* of the realized actions with project's general and specific aims
- the esteem of impacts on project's direct and indirect target groups

Then, Mr. Paiano gave a general overview on the assessment tools applied during the project life-cycle to perform:

#### A. Progress Assessment

Specific online questionnaires, available as google form to evaluate both transnational project meetings and the LTTA. The online form allowed a quick and easy filling of the assessment tools.

The evaluation results were elaborated in proper evaluation reports, drafted for each activity and share with partners.

This meeting's session was closed by the sharing with all partners of the link to evaluate the last technical meeting in Florence, as final action for the progress assessment (available from this link: https://forms.gle/93NJf4MDrTwvAFwQ9)

#### **B. Final Assessment**

To evaluate the pedagogical relevance and the whole quality of the intellectual outputs in their final version as well as the effectiveness of partners' collaboration and cooperation to achieve the project's goals, a tailored final assessment will be done by all partners.

So, Mr. Paiano showed the general features of this last assessment phase, explaining that it will be performed by partners (under UMA supervision) through a tailored <u>qualitative questionnaire</u> aimed to explore such dimensions as:

1. time management and respect of the planned deadlines

- 2. implementation strategy
- 3. partners' contributions

4. the results achieved in implementing the output (scientific, educational, technical, organizational)

5. overall quality of the final version of the output (eg, completeness, quality, usability, effectiveness, functionality, etc.).

Then, Prof. Dolores Madrid and Prof Rocio Pasqual showed the tasks and the tools to be used by all partners to make the final impact evaluation of the whole READ-COM project experience:
